- 1.1 Jaipur Metro Rail Corporation (JMRC) Ltd. invites Request for proposal **“Procurement of 02 Nos. BNR (Bank Note Recycler) with integration in Ticket Vending Machines (TVM) installed at station (1A) for JMRC” (Single stage Single envelope method)** through e-tendering process
