### **Annexure –A**

1. Required services should be strictly as per descriptions mentioned in Annexure-B.
2. Offer from the firms who do not have a valid GST No. will not be entertained. GST No. Should be clearly indicated in offer and Enclose Copy of GST Registration Certificate.
3. Order will be given to one firm, based on overall lowest rates of item.
4. The above material shall be delivered (after repair) at Custody Store Section, Room no. D20, Train maintenance Depot, Bhriгу Path, Mansarovar –Jaipur-302020 to JE/Custody Store, Cont. no. 07728895713.
5. The rates quoted shall be For JMRC office, Mansarovar Metro Depot, Jaipur-302020, inclusive of all expenses i.e. all taxes (excluding GST), and transportation charges etc; no other charges shall be paid by JMRC. GST will be paid at rate applicable at the time of billing.

#### **6. Liquidated Damages:**

If material not supplied within contract period as mentioned in NIB, then contractor shall be held responsible for liquidated damages. The liquidated damages is compensation of loss on account of late delivery (actually incurred as well as notional) where loss is pre-estimated and mutually agreed to procuring entity may recover from the contractor, as agreed, the liquidated damages a sum equivalent to 0.5 (one half) percent of the prices of any portion of stores delivered late, for each week or part thereof of delay. The total damages shall not exceed 10(Ten) percent of the value of delayed goods. However decision of procuring entity shall be final in this regard. The offer shall be unconditional and duly signed. Delivery period may be extended with or without penalty if approved by competent authority on request of contractor.

7. Warranty: 06 months from date of supply (after repair at JMRC Depot).

#### **8. Other Terms and Condition:**

- a.) Subject to the condition of contract, services shall be executed within the time specified in the PO.
- b.) Faulty Emergency Inverter shall be offered by JMRC Engineer to the representative of the bidder along with delivery note/Gate pass.
- c.) Bidder shall provide the Suitable packing arrangement for faulty emergency inverter (if required).
- d.) The freight charges both ways from JMRC depot to Bidders workshop and back will be borne by the bidder at their own cost. Same will be including in repairing charges as per accepted bill of quantity.
- e.) Bidder will be informed sufficiently in advance (07 days) about availability of faulty emergency inverters. The Bidder shall lift faulty emergency inverters within three working days from the date of intimation and shall return the lifted faulty emergency inverters after completion of repairing work within a max 15 calendar days from the day of lifting.
