### **NOTIFICATION**

## Sub.:- Metro Railways (Carriage and Ticket) Rules, 2014.

In addition to the one baggage containing personal belongings not exceeding 60 cm x 45 cm x 25 cm in size and 15 Kgs in gross weight, Jaipur Metro Rail Corporation, in exercise of the powers conferred on it under Rule 3 of the Metro Railways (Carriage and Ticket) Rules, 2014, allows its passengers and other authorized persons to carry the following goods in Jaipur Metro Railway [definition of metro railway as specified in the Metro Railways (Operations and Maintenance) Act, 2002], subject to the conditions noted against each item:

- 1. allowed to carry packed eatables, but not allowed to consume the same;
- 2. allowed to carry packed or sealed water bottles, beverages, etc., and, if necessary, consume the same but without littering. However, no alcoholic, sedative, narcotic or other stimulant drinks, etc. are allowed to be consumed;
- 3. allowed to carry cigarette, biddi, pan masala, etc., but not allowed to consume the same as smoking is completely prohibited;
- 4. allowed to carry safety match box or lighter, but not allowed to open, use or ignite the same;
- 5. allowed to carry and use mobiles and cameras for photography. However, videography and/ or recording gadgets can be used only with prior approval of PRO, JMRC and specific permission of the Station Controller on duty;

The above items are allowed subject to the general stipulation that drunkenness or nuisance or act of indecency or interfering in any way with the comfort of any passenger of metro railway will always constitute an offence punishable with fine upto Rs. 500 and forfeiture of paid fare or removal from carriage under Section 59 (1) of Metro Railways (Operation and Maintenance) Act, 2002.

Any items, goods, etc., which are not otherwise permitted/ allowed to be carried or to be consumed/ used at public places in Jaipur City area by virtue of extant stipulations, notifications, orders, etc. issued by competent statutory authorities, shall continue to be disallowed to be carried or consumed/ used in Jaipur Metro Railway.
