Minutes of meeting held on 15.02.2018 at 11.45 AM

A meeting was held under the chairmanship of Chief Secretary to discuss the issue of displaying multi coloured red, blue and white lights on vehicles on official duties designated for emergency and disaster management duties as per the notification dated 1st May, 2017 issued by Ministry of Road Transport and Highways.

Following officers were present:-

- 1. Sh. Deepak Upreti, ACS Home.
- 2. Sh. Shailendra Agarwal, ACS Transport and Transport Commissioner.
- 3. Sh. OP Galhotra, DGP.
- 4. Sh. NRK Reddy, Addl. DGP, Law and Order.

Transport Commissioner brought out the fact that the Ministry of Road Transport and Highways had issued a notification on 1st May, 2017 whereby stopping of use of red and blue beacons and permitted use of multicoloured red blue and white lights on notified vehicles for designated services was introduced by Government of India. ACS Home and DGP sought the use of multicolour flashing lights on the vehicles used for maintenance of law and order by police officers of the district administration involved in prevention of crime and maintenance of law and order.

After elaborate discussions, following decisions were taken.

- ACS Home will send a note bringing out the justification for permission of use of multicolour lights on vehicles by authorities responsible for maintenance of law and order in the police department and in district administration.
- 2. Transport Department will process the note for permitting the use of multicolour red, blue and white light by District Magistrates, Additional

District Magistrates, Sub Divisional Magistrates, Tehsildars and Executive Magistrates as also by Superintendents of Police, Additional SPs, Deputy ASPs posted in the districts.

3. In addition the vehicles used by Commandants, Deputy Commandants and Assistant Commandants in RAC would also be considered for use of the same facility.

The meeting ended with thanks to the chair.
