In exercise of the powers conferred by section 4B of the Rajasthan Motor Vehicles Taxation Act, 1951 (Rajasthan Act No 11 of 1951) and in supersession of this Department's Notification No F 6 (179) /Pari / Tax / Hqrs /95/7B, dated 31-03-2000 (as amended from time to time),the State Government hereby prescribes the rate of Special road tax on stage carriages owned by a fleet owner of this State as specified in Col. No. 2 of the table appended here, at the rates specified against each in Col. No. 3 thereof:-

Provided that the amount of Special Road Tax payable under this notification shall not exceed Rs 25000/- (twenty five thousand) for one Motor vehicle. **Note:** In addition to tax payable under this notification there shall be paid by the owner or person having possession or control of a motor vehicle, any tax or penalty as was payable under this Act for any period prior to the coming into force of this notification issued under the provisions of the chapter V of the Rajasthan Finance Act, 1997 at such rates as were applicable to such vehicles from time to time.

Explanation : (1) In case of vehicles plying under temporary permit, special road tax shall be payable separately at the rates as specified in this department notification No. F 6 (96) Pari/tax/Hqrs/III/6-O Dated 1-08-2007

(2.) The cost of the chassis shall be calculated as per Rule 42 of the Rajasthan Motor Vehicles Taxation Rules, 1951.
